MESSAGE FROM OUR CONVENOR

After the trials and tribulations of 2020/21 and the impact of the Covid pandemic, it would have been nice to be able to say that 2021/22 marked a return to normality and calmer days. However, while it would have been difficult to match the disruption of the initial wave of Covid, the impact of the pandemic has carried on throughout the whole of the reporting year and the end of year was marked by a number of staff and volunteers experiencing their first encounter with the dreaded virus.

Having said that, the year has seen us largely return to the provision of our 2 weekly foodbanks in Raploch and St Ninians, with the occasional shift back to a full home delivery service as a new wave of Covid has hit. Thanks to our wonderful staff and volunteers, we have continued to deliver a full service whatever the challenges, with volunteers often meeting calls for assistance at short notice as Covid has led to gaps in our rotas. So can I say a big Thank You to all of our regular and irregular volunteers who have always managed to hold the fort, whatever the circumstances. Indeed, the quality of our Volunteers has recently been recognised with Start Up having been given the Queens Voluntary Award for Service, the highest accolade available for volunteers. Well deserved!

We continue to rely heavily on our local community, both personal and business, for their generosity, with donations in the form of food and cash holding up well during the year. These donations are vital to allow us to deliver the services we deliver across the Stirling area, so another big Thank You is due to our supportive community.

During the year we have continued to work in tandem with a variety of local agencies in an atmosphere of mutual support. This has included working with the likes of Citizens Advice on the TRI initiative in rural areas, NHS Forth Valley, Forth Valley College and others on the GROW initiative and Stirling Council on Starter Packs for new tenants in social rented housing. Hopefully, between us, these agencies working together can provide outcomes that are greater than the sum of their parts!

We are aware of the ongoing challenges that face the less well off in our local community as the reporting year has come to an end, with the impact of inflation and energy prices in particular. Start Up Stirling will continue to do what it can, with the support of our community, to address poverty, and food poverty in particular, throughout 2022/23 and beyond.

ABOUT US - AIMS & OBJECTIVES

The organisation's purposes are:

The relief of poverty; the prevention or relief of suffering and distress caused by poverty through the compassionate provision of food and other practical support and services required by the communities we serve in the Stirling Council area, working in partnership with other regional agencies while maintaining the dignity of our beneficiaries.

OUR SERVICES - WHAT WE DO AND HOW IT HELPS THOSE IN HARDSHIP

Start Up Stirling provides a portfolio of key services to individuals and families experiencing hardship in the Stirling area. The organisation has been operating in the area since 1994, when a group of local churches came together to collect goods to provide to young people who had been homeless and were entering their first home of their own. Our assistance to local people has developed from that time in response to the feedback we receive from those accessing our services and the changing needs in society. In the recent past we have provided three main services, Home Starter Packs, Crisis Food Banks and "Beyond the Food Bank" Support Services. All of these in different ways have assisted in alleviating the effects of deprivation. All of these services were profoundly affected by the pandemic and while Food Bank and Home Starter Pack Services have been restored in full we are still in the process of restoring our support services.

Crisis Food Banks

The first Start Up Stirling foodbank was opened in 2012, with recognition at that time of the extent of local food poverty. At the beginning of 2020 we were operating two foodbanks, in different town centre locations, as well as a mobile delivery service for those unable to access the food banks. From mid-March 2020, the social distancing provisions related to the Covid-19 Pandemic made that previous model unsustainable and we shifted to a full home delivery service. During 2021/22, we have had to switch between two different modes of service delivery (Foodbank/Home Delivery), often at very short notice, as Scotland has moved into and out of lockdown and as Covid has hit both staff and volunteers. In early January 2022 we were forced to revert briefly to 100% home delivery, but had returned to more normal levels of around 50-60% home delivery by the end of March.

By the end of the year we had largely returned to our Pre-Covid service at foodbanks. We have introduced a "Shopping List" Service for our clients which helps us to avoid providing foodstuffs that our clients don't want and won't use and we continue to provide as much fresh food as we can, both fruit and vegetables. At Christmas, through our ongoing relationship with Forth Valley College, we have also been able to provide pre-cooked frozen meals for our clients prepared by the college and its students as part of their course activities. In addition, donated Christmas presents were passed on to our clients both adult and children.

We have also been working closely with Citizens Advice Bureau (CAB) who provide a staff presence at our foodbanks and have actively increased this resource in a response to demand for advice on fuel poverty, and we have provided additional support to clients in the form of school bags and summer activity bags and a limited quantity of school uniforms.

During most of the year referrals closely matched those of the previous year, with the exception of the period immediately after the first lockdown in March 2021. However, in early 2022 we have started to see a significant year on year increase in food bank referrals when compared to the same period for the previous year. There is an obvious concern that this is linked to the impact of inflation and fuel cost increases on Stirling residents and we will be monitoring this closely over the rest of the year.

Starter Packs

Starter Packs have been provided to people commencing new tenancies, following homelessness, or a crisis or significant change to their personal situation. A Standard Starter Pack includes crockery and cutlery, pots and pans, cooking utensils, towels, and cleaning products, plus basic kitchen cupboard items, such as tea, coffee, sugar, salt and pepper. Supplementary assistance packs are also available and are provided in response to the results of a client needs assessment. We have also provided Emergency Packs to people who are homeless or in temporary accommodation.

"It was very useful as I had barely anything. I didn't have to worry about how I was possibly going to afford anything but I got everything I needed and this really eased my anxieties".

The impact of the pandemic limited the amount of social rehousing in 2021, and helped reduce the demand for Starter & Welcome packs, although the demand for emergency packs grew. However, demand for Packs has increased significantly and gone past pre-pandemic levels with additional demand continuing into 2022/23. This Service continues to be supported with some funding from Stirling Council.



Beyond The Foodbank TRI

Since January 2017 Start Up Stirling had operated a 'Beyond the Food Bank' support service to some of our more vulnerable clients. Over a sandwich lunch this aimed to provide the time, place and space for people to explore how to improve their individual situation. However, of equal benefit to many was the peer support and social contact the group also provided, helping to reduce their social isolation. Though much appreciated by the clients this service was costly in staff and volunteer time and had difficulty in demonstrating any objective effectiveness.

In October 2019, Start Up Stirling, in collaboration with CAB-Stirling, were successful in a funding application to the Scottish Government to deliver a new service, 'Tackling Rural Isolation' (TRI), predominantly in the rural North & West areas of Stirling District. It was intended that Start Up Stirling would provide crisis food support and the practical and emotional element of the Client Support Service; CAB would provide support and advice on fuel/energy and finance. Transition funding was obtained to move the Client Support Service operation into the new Tackling Rural Isolation service from April 2020 onwards.

The development of this Service has proved particularly problematical because of the impact of Covid, requiring as it does a largely face-to-face service delivery model. The regular changes in lockdown rules and requirements have been frustrating and the resulting delays in service development have led to significant staff turnover, with the most recent post holder departing in May 2022. However, as at the time of writing we are hoping that we are now staffed up and free from further lockdown and should be able to develop this service accordingly, in partnership with CAB, during 2022/23.

GROW Project

During 2021/22, and in conjunction with partners Stirling Community Enterprise, NHS Forth Valley, Forth Valley College and Forth Environment Link, we have established the GROW project. Initially based at Kildean in Raploch the project aims to support the local community in planting, growing, harvesting cooking and eating home grown food. Having secured some initial funding, the scheme is very much in its infancy and Start Up will continue to monitor its progress and consider how any food produced can be best used to assist those in need.

Stirling Food Partnership

In early 2022 the Charity joined the Stirling Food Partnership, an organisation aimed at bringing together a variety of local agencies involved in making best use of food in the Stirling area. Our General Manager Andy Ireland, now regularly attends meeting of the group and will be providing input and feedback over the coming months. Our aim is to identify any possible gap in the provision of food support for those in need and also to avoid any duplication of services with other agencies.

Warehouse

The pandemic caused the charity to significantly change our working practices to facilitate social distancing and different models of service delivery. They were expertly managed by our Warehouse and Facilities Manager Gerry McPeake and his superb team of volunteers as the food delivery model changed repeatedly throughout the year, often at short notice.

After the short term use of the Albert Halls and Hillpark Centre in Bannockburn during 2020 and early 2021 all of our stock is now back at our Springkerse base, the only extra storage facility being 2 containers used for holding long dated stock. During the year we have also used some of our funding to increase our freezer capacity to allow us to buy and store more fresh food and for longer storage of meat and other produce suitable for chilling and freezing.



Staffing

In the course of the reporting year there have again been a number of changes in the staffing team. In April, our Client Services Manager, Andy Ireland, was appointed as acting General Manager following the resignation of Gillian Hughes from the post. This appointment was made permanent in July 2021. Following the departure of Susan Young at the beginning of the reporting year, a vacancy at Client Support Worker was filled by Pauline Henderson in the autumn. A second fundraiser post was also approved to support the work previously done by Julie Christie and Morag Dorrian was appointed in early 2022. Unfortunately, since the end of the reporting year both Pauline and Morag have left us, and the fundraising post currently remains unfilled, with Gail MacDonald recently having taken on the Client Support Worker role.

Volunteering

2020/21 was a disruptive year for volunteers with many being "furloughed" due to Covid, but with many new volunteers coming on board at the same time. During 2021/22 the volunteers have remained the lifeblood of the charity, helping to run the foodbanks, food delivery and the warehouse as well as supporting with administration and guidance initiatives including assisting our volunteer co-ordinator Tricia to pull together a comprehensive Volunteer Pack. Volunteers have taken on extra responsibilities as Covid has continued to impact on staff and volunteer availability over the year, often doing extra (or different) tasks at short notice and coming in to substitute for regulars who are absent as a result of the pandemic.

During the year we were nominated for the Queens Award for Voluntary Service (QAVS).

An initial application process was completed and this was followed by an interview with the Lord Lieutenant and his deputies followed by a comprehensive visit to the warehouse to see first-hand what our volunteers do. In early June 2022, we were awarded the QAVS—the highest national award for a voluntary organisation. It has been extremely pleasing for all involved with the Charity to see the endeavours of our wonderful volunteers recognised in this way.

Food Donations

In the confusion of the early phase of the pandemic, food donations fell away to an extent, but recovered as donors established their new household purchasing behaviours. Meanwhile we are very grateful to the supermarkets who despite their own many problems maintained or even extended our donation stations and gave us access to short-dated food. We are grateful to the Stirling Council Criminal Justice Team who increased the time they gave us and took on all the collection from supermarkets. We are as ever grateful to the many who donate to us when they shop for themselves.

Besides donated food we continue to make purchases to ensure a supply of fresh food and to fill shortfalls in particular items. We also subscribe to Fareshare who distribute surplus food to us and other similar charities.

Fundraising and Community Engagement

Fundraising events and in person collection had been largely in abeyance since the start of the pandemic. Community donation had been routed online and an active campaign on social media maintained. Thanks are due to our loyal supporters who multiply the effectiveness of such campaigns by liking and sharing our posts. Through all this the generosity of the public, local businesses, grant-giving bodies and government agencies has been immense. We are humbled to realise the extent to which we are trusted by them to channel their resources where they are needed.

During 2021/22 we did manage to reintroduce more fundraising activities. These include:

- The Get Set for Summer and School campaign in the Summer of 2021
- Communities Beyond Covid in the Autumn
- Nobody Forgotten this Christmas Appeal in December
- The Virtual Kiltwalk in April 2021
- Footsteps for your Foodbank in February 2022

We are also grateful for the support of the major funders including HSBC, Nationwide, Robertson Trust, Bank of Scotland, the Scottish Government & Stirling Council for their continued support.

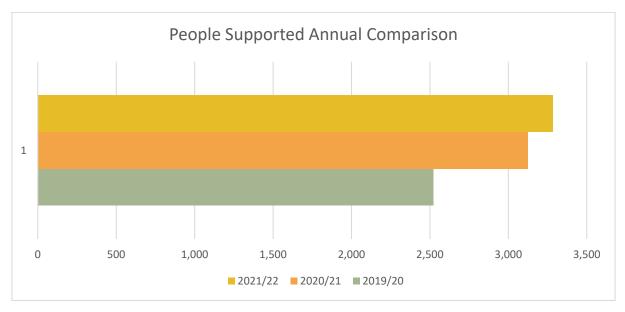

PATTERN OF ACTIVITY

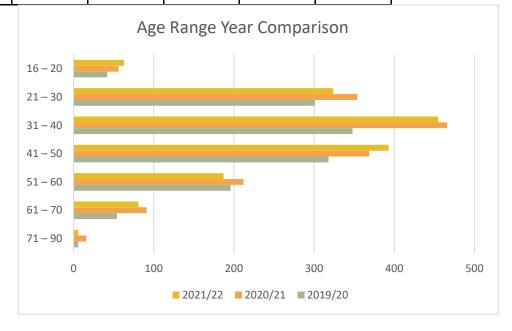

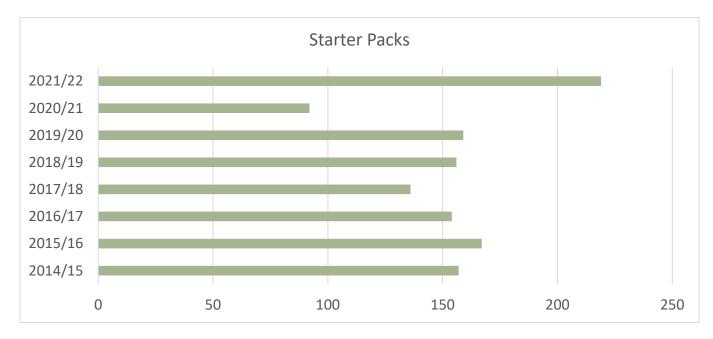
As our partners in Stirling Council's Housing and Homeless teams returned to full capacity we saw a massive increase in Home Starter Packs being distributed.

We also saw significant increase in Emergency Food packs, Welcome packs and Hygiene packs.

Emergency food packs are 1 day survival packs issued to those who are homeless.

Welcome Packs are short term food packs issued to those entering temporary accommodation.

Hygiene packs are issued via the Homeless teams and the Salvation Army to those in need in Stirling.



Prior to lockdown we would average 154 Starter packs a year.

If we take the last 2 years as an average it is consistent with previous years.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Start Up Stirling was incorporated as a Scottish Charitable Incorporated Organisation (SCIO) on 6th March 2014. All historical charitable activities undertaken in the name of Start Up Stirling were at this time subsumed into the new organisation. The charity's structure and governance operate in accordance with the arrangements set out in its governing document, namely the Start Up SCIO Constitution version 3. At its General Meeting in November 2021 the constitution was updated and modernised to clarify the charity objectives to remove some operational anomalies and to simplify the language, removing possible ambiguity.

The charity's activities are overseen by a Board of Trustees. This group is formed from the membership of the charity. All registered members are eligible to stand for and be elected to the Board. Trustee nomination and election normally takes place at the charity's annual general meeting. The Board of Trustees may at their discretion co-opt additional individual members onto the Board.

Management of the charity's operations is delegated to designated members of staff in accordance with a Board approved Scheme of Delegation. Staff are supported by volunteers in the delivery of the charity's various services. In certain areas the Board have at various times introduced functional working groups involving staff, volunteers and trustees. The working group approach is used primarily in the areas of warehousing and logistics, fundraising and administrative support.

In this year when meetings in person of groups from multiple households has continued to be difficult, the Board have met using teleconference facilities. The AGM in November was held in person with the option to dial in remotely.

The management of risk is an important responsibility of the Board of Trustees and policies and procedures have been established in key areas of potential risk. A regular process of policy review has now been started to ensure that policies all remain appropriate and conform to relevant legislation and guidance. In addition, the charity maintains PVG accreditation for key staff and volunteers involved in client related activities or when serving as trustees.

RESERVES & RESERVES POLICY

Reserves are held to ensure that Start Up Stirling can continue to deliver services to the charity's beneficiaries. The charity delivers a range of services and carries out a number of projects that involve the employment of staff and also certain longer-term contractual commitments, specifically premises rental for the charity's main warehouse operating unit.

The Board of Trustees have examined the requirement for unrestricted reserves and determined a policy of holding reserves equivalent to the lesser of; three months staff costs plus the balance of contractually committed rent on the warehouse operating unit, or three months total operating costs.

The Trustees note that at 31 March 2022 the unrestricted funds of £365,717 were in excess of the required reserves under the Reserves policy. The Trustees remain cautious as to the level of reserves required for the charity, as the UK enters into a further period of change and as we complete the emergence from the COVID pandemic. The Trustees are aware that reliance on foodbanks may rise in the next 2 years due to the impact of inflation on domestic household budgets.

In the coming year the Trustees will look at setting aside an element of the unrestricted funds in designated funds. Designated funds are those unrestricted funds that have been allocated at the Trustees' discretion for particular purposes. They can be unallocated subsequently should circumstances change. The Trustees will review their tangible asset requirements and an appropriate level of designated funds necessary for the ongoing requirements of the charity in the coming year.

WHERE OUR INCOME COMES FROM

Community donations – a wide variety of individuals and groups make regular and one-off donations to the charity via our website, using online payment services offered by the likes of Facebook. A significant proportion of the monies received come from local churches and faith bodies, community groups and schools. During the year we benefited from £140,132 in donations (2020/21: £245,440). We have been overwhelmed by the level of donations from individuals, groups and businesses during this very difficult pandemic and these donations have ensured that the charity has been able to continue to deliver its vital services.

Grants and Statutory funding – we have a number of established relationships with public sector and other grant awarding bodies who provide financial support to a number of specific aspects of the charity's operations. During 2021/22 the charity received income of £275,174 in relation to grants and statutory funding (2020/21: £202,307). We are extremely grateful for the support that we have received this year as it has allowed us to continue to adapt our approach to service delivery whilst complying with social distancing restrictions.

The details of the grant and statutory income received, and the associated level of expenditure is shown in Notes 3 and 4 of the Annual Accounts.

HOW WE SPEND THE MONEY

Home Starter Packs —this service involves the purchasing of various household items, bedding and packaging. A dedicated team of volunteers working out of our warehouse unit undertake the sorting and packaging of the support packs which are distributed to clients with the assistance of Stirling Council Homelessness Partnership.

Crisis Food Bank — our main gateway service is coordinated by Support Worker members of staff who liaise with referral organisations to organise a series of face to face food bank sessions in the Stirling area. These sessions are run by members of our volunteer supporter team. In addition to staffing costs, we incur expenditure on premises rental and related services, vehicle purchase and running costs, purchasing fresh produce, meat and dairy food items. In the year to 31 March 2022 we continued to adapt our normal service deliver whenever we were unable to run food bank sessions due to Covid. We receive, sort and store donated food and other items in our warehouse unit that is overseen by our Warehouse & Facilities Manager.

Crisis Food Home Delivery – our services are available across the entire Stirling Council catchment area. We operate our own transport in the form of two vans that are driven by a team of volunteer drivers who deliver food and other goods to clients who are unable to attend our face to face food banks. The vehicles are also used to collect food donations from local supermarkets and pick-up community food donations from across the area.

Beyond the Food Bank – this additional support service is organised by Support Worker members of staff who liaise with individual clients. These sessions are run by members of our volunteer support team. In addition to staffing costs, we incur expenditure on the rental of external facilities and catering for community meals and other similar events. These sessions were curtailed due to the COVID-19 pandemic, but will be reintroduced in 2022/23.

General management, Fundraising, Volunteer Coordination and Other Support – a key part of sustaining the charities activities is our engagement with donors and supporters, including a group of around one-hundred and ten local volunteers. We employ a General Manager, 2 Fundraising Managers and a Volunteer & Training Coordinator on a part-time basis to coordinate a variety of initiatives aimed at maintaining and developing the flow of funds, food and other donations to the charity. We also employ an Office Administrator to support the operations of the charity, a Warehouse Facilities Manager and 2 Support Workers.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF START UP STIRLING

I report on the accounts of the charity for the year ended 31st March 2022 which are set out on pages 23 to 40.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the 2006 Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Preparation

The financial statements have been prepared under the historic cost convention and in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) applicable to charities preparing accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) effect from 1st January 2015. The Financial Reporting Standards applicable in the UK and Republic of Ireland (FRS102), the Companies Act (2006), the Charities and Trustees Investment (Scotland) Act (2005) and the Charities Accounts (Scotland) Regulations (2006) as amended.

Going Concern

The Board of Trustees are of the opinion that the charity can continue to meet its obligations as they fall due for the foreseeable future and have therefore prepared the financial statements on a going concern basis.

Based on the annual budget approved by the Trustees for the year to 31 March 2023 the charity has sufficient cash held at the bank to cover a full year's worth of expenditure from the date that this annual report was approved by the Trustees. As a direct result of this the Trustees will continue to meet its obligations as they fall due for the foreseeable future.

Deferred income

Income received from a third party is deferred and carried on the balance sheet as a liability where the entitlement for use is not met. Refer to Note 10 for details of deferred income.

Expenditure

All expenditure is accounted for on an accrual basis and is recognised in the period in which it is incurred. Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services in pursuit of its charitable purposes. Reported expenditure includes costs attributed to such charitable activities and also costs of an indirect nature necessary to support the delivery of these services.

Fund accounting

Funds held by the charity are either in an unrestricted general fund that is used in pursuit of the organisation's overall charitable purposes, or in a restricted fund. Restrictions applied to the use of funds may be stipulated by donors at the point that monies are made available to the charity. The charity's Board of Trustees may at their discretion decide to set aside funds for a specific charitable purpose and thereby designate restrictions on the use of funds.

General reserves are unrestricted funds that are available for use at the Trustees' discretion for the furtherance of the charity's objectives. Designated funds are funds set aside at the discretion of the Board for specific purposes which would otherwise form part of unrestricted funds.

The Designated Reserve reflects unrestricted funds earmarked for the replacement of tangible fixed assets at the end of their useful lives and required for the effective continuation of the charity's activities.

The General Reserve reflects the balance of unrestricted and undesignated funds of the charity.

Fixed assets

Tangible fixed assets are measured at historic cost less accumulated depreciation and any accumulated impairment losses. Depreciation is provided on all tangible fixed assets and charged to the Income & Expenditure account on a straight-line basis. Refer to Note 7 for details of the charities tangible fixed assets and related deprecation charges.

Cash and cash equivalents

Cash and cash equivalents include cash at bank and in hand. In the Statement of Cash Flows, cash and cash equivalents are shown net of any bank overdrafts, where applicable. Bank overdrafts are reported as borrowing liabilities on the Statement of Financial Position.

Debtors and prepayments

The organisation is a registered charity and does not carry out any trading activities. Consequently, reported debtors and prepayments relate to the proportion of any goods or services paid for by the charity where an element remains to be consumed in a future period.

Creditors

Short-term creditors are measured at transaction price, normally the invoice price. Reported creditors include employer social security and tax liabilities. Loans and other financial liabilities are initially recognised at transaction price net of any transaction costs and consequently measured at amortised cost determined using the effective interest method.

Taxation

The organisation is a registered charity and does not carry out any trading or other taxable activities. Consequently, no provision is made for Corporation Tax. Other taxes, including VAT, are recognised as an expense in the period to which they relate. The charity claims Gift Aid tax relief on eligible donations in accordance with applicable HMRC regulations.

Pensions

Employer pension contributions to a NEST money purchase plan are reported as operating costs and recognised as an expense in the period to which they relate.

NOTE 2 – CRITICAL ACCOUNTING JUDGEMENTS

Estimates and judgements in relation to the charity's financial position form part of a continual and ongoing process of financial management. Where accounting judgements are made these are based on historical experience and other relevant factors, including expectations of future events that are believed to be reasonable under the circumstances.
